Results of Scheme Meeting and Notice of Second Court Hearing

Results of Scheme Meeting

Following today's Scheme Meeting, Sunland Group Limited (**Sunland**) is pleased to announce that Sunland Shareholders have voted in favour of the proposed acquisition of Sunland by Sun Holdings GC Pty Ltd (ACN 677 077 771) (**Sun Holdings**) by way of scheme of arrangement (**Scheme**).

In accordance with the Notice of Scheme Meeting included in the scheme booklet dated 3 December 2024 (**Scheme Booklet**) and section 411(4)(a) of the *Corporations Act 2001* (Cth) (**Corporations Act**), Sunland advises that the Scheme Resolution to approve the Scheme was passed by the Requisite Majorities of Sunland Shareholders at the Scheme Meeting earlier today.

In summary:

- 89.66% of Sunland Shareholders present and voting at the Scheme Meeting (either in person or by proxy) were in favour of the Scheme Resolution; and
- 93.17% of the votes cast by Sunland Shareholders were in favour of the Scheme Resolution.

Unless otherwise indicated, capitalised terms used in this announcement have the meaning given to them in the Scheme Booklet.

Notice of Second Court Hearing

To all members of Sunland, **TAKE NOTICE** that at 3:00pm on Monday, 3 February 2025, the Supreme Court of New South Wales (**Court**) at 184 Phillip Street, Sydney NSW 2000 will hear an application by Sunland (**Second Court Hearing**) seeking the approval of the scheme of arrangement between Sunland and its members as proposed by the resolution passed by the extraordinary meeting of Sunland Shareholders held on 20 January 2025.

The proposed Scheme as approved by the meeting is in the form of scheme of arrangement previously sent to shareholders by email and post by Link Market Services, on behalf of Sunland, on or around 9 December 2024. If you wish to oppose the approval of the Scheme, you must file and serve on Sunland a notice of appearance, in the prescribed form, together with any affidavit on which you wish to rely on at the hearing. The notice of appearance and affidavit must be served on Sunland at its address for service 1 day before the date fixed for hearing of the application.

Next steps

If the Court approves the Scheme under section 411(4)(b) of the Corporations Act at the Second Court Hearing, the Scheme will be formally approved. Following this, Sunland will receive Court orders to confirm that the Scheme will be legally binding on Sunland Shareholders.

Sunland proposes to lodge an office copy of the Court orders with the Australian Securities and Investments Commission (ASIC) on 4 February 2025, at which time the Scheme will become Effective.

It is then expected that:

- Sunland members who were on the share register on the Permitted Dividend Record Date on 14 January 2025 will receive the Permitted Dividend from Sunland on 19 February 2025; and
- the Scheme will be implemented on 20 February 2025 and Sunland members who are on the share register on the Record Date will receive their elected Scheme Consideration.
